Conveyance Allowance air travel information for school year 2017

Why is there a Conveyance Allowance Scheme?

The Conveyance Allowance Scheme helps to meet some of the cost families face to transport their child from home on a **Bass Strait Island** to school or college on mainland Tasmania or Australia.

What is Conveyance Allowance?

It is a payment for eligible families to help with part of the cost to transport their child from home to the school.

What are the eligibility criteria?

To be eligible, a child must meet each of the following:

- be school aged (turning between the ages of 5 and 18 in 2017)
- be enrolled for the full year, in full time education (Kindergarten is considered full time education) at a school recognised by the Department of Education, and
- live on a Bass Strait Island.

A child must also meet one of the following:

- is in grade II or I2, or
- needs to attend an educationally appropriate school on mainland Tasmania or Australia.

What is the amount of Conveyance Allowance?

The payment is equivalent to nine capped return flights and an allowance of \$55 for associated ground travel per return trip in a school year.

It is paid in two payments, the:

- first is made in June, and the
- second is made in December.

When to apply?

Applications must be received by 15 May 2017 to be assessed for the full school year.

Applications received after 15 May 2017 will only be assessed for terms 3 and 4.

No applications will be accepted after 15 November 2017 for the current school year.

A new application is required every school year.

How to apply?

To apply for Conveyance Allowance, the Conveyance Allowance air travel application form for school year 2017 must be used (see below).

A new application is required each school year using the form that is issued for that school year. If an application is not made on the current version, a new application form will need to be completed.



How to complete the form?

The application must have attached a letter from the school (which the child is attending) stating the child's full name, date of birth, home address and confirmation of enrolment at that school.

If the child is in grade 11 or 12	A letter of enrolment from the school the child is attending

How to submit a Conveyance Allowance application?

Send the form and any supporting evidence via:

- in person: at any Service Tasmania shop for your nearest location visit www.service.tas.gov.au

How is an application assessed?

An application is assessed to ensure that each child listed in the application meets the eligibility criteria. This includes checking evidence provided with the application, along with other information that we have available to us, for example:

- the child's enrolment at school through the Department of Education and/or the school in which the child is enrolled
- information contained in the register of driver licensing and vehicle registration
- information available to the Department of State Growth, and
- records that are in the public domain (telephone books etc).

What cross-checks are made before making payment?

It takes time to assess a child's eligibility and to ensure the correct payment is made thoroughly and consistently.

To ensure the child continues to be eligible for Conveyance Allowance and the correct amount is paid, we may check:

- the child's attendance/enrolment at school, through the school and/or the Department of Education
- the child's home address matches the address on the application
- records in the public domain
- information that is available to the Department of State Growth, and
- information contained in the register of driver licensing and vehicle registration.

These checks may result in deductions to a payment or recovering overpayment from the family.

How do I notify when circumstances change?

A notification (for example a change of address, bank account details or school enrolment) must be made within 7 days. To notify a change of circumstance, email passenger:transport@stategrowth.tas.gov.au

It is important to let us know when circumstances change as the child may no longer be eligible for Conveyance Allowance, or it may lead to an overpayment. If an overpayment is made, the overpayment will be recovered.
