An application fee of \$40.00 per card (GST incl.) applies for new applications in the Bulk Fuel Purchase Scheme plus a \$25.00 (GST incl.) annual fee, due in November of each year after the initial year. An application for vehicles replacing existing vehicles (either buses or support vehicles) that already participate in the Bulk Fuel Purchase Scheme, are *not* charged a fee other than the annual fee. All fees are payable either at the time of application by cheque or money order made payable to: the Department of State Growth or it can be deducted from the next available operator payment to be processed. The annual fee can be deducted from your November payment(s). **DO NOT SEND CASH IN MAIL.**
