

National Training Framework for Temporary Traffic Management Theory Only Course Information



A theory only course (no post course practical required) is designed for workers who do not directly undertake temporary traffic management roles at worksites, that is they need to know about traffic management, but do not perform a traditional traffic management role. This training is referred to as Non Practitioner training in Tasmania.

What Is The Course Content?

A learner will complete all the theory, theory assessment and any simulated assessment but will not complete the post course practical training required.

For example – if completing Traffic Management Implementer 1 non-practitioner course over two days a learner will participate in all class theory, theory assessment and simulated assessment. If a learner successfully completes the theory and simulated assessment they will be issued with a Certificate of Completion.

Will A Skill Set Be Issued?

No - on successful completion of the course a learner will receive a Statement of Completion only.

What If A Learner Wishes Receive The Skill Set

If a learner wishes to complete the full skill set they will need to enrol in and complete the relevant skill set.

Is A Refresher Required?

More information regarding refreshers will be available late 2024, at this stage it is anticipated a non-practitioner will be required to complete refresher training every three years.

Who Can Deliver This Course?

Only Approved Training Providers may deliver a theory only course, a list of Approved Training Providers is available <u>Approved Training Providers | Austroads</u>

Additional Information for Approved Training Providers (ATPs)

If an ATP wishes to deliver a non-practitioner course in Tasmania they must:

- Contact <u>TTMTraining@austroads.com.au</u> to seek permission to deliver these courses.
 Once approval is given from the Department of State Growth (DSG) a variation of contract will be organised by Austroads to add the theory only courses to an ATPs scope.
- 2. Ensure that learners meet any pre-requisites required for Units of Competency and any entry requirements for the jurisdiction.
- 3. Ensure that the learner understands that by completing the theory only course they do not have the qualification to work on a live road. If this is a requirement they must enrol in and successfully complete the relevant Temporary Traffic Management Skill Set.
- 4. If the learner successfully completes the requirements for the theory only course a Statement of Completion must be issued.
 - On the Statement of Completion the following words must be included.

 This statement provides the individual with non-practitioner status which excludes the individual from performing the function of a insert either Traffic Controller, Traffic Management Implementer or Traffic Management Designer
- 5. As per other TTM Training Programs (and service agreement) a course pro-forma must be completed prior to and after commencement of the course and copies of Statements of Completions must be sent to Austroads.
