If you wish to drive any other kind of Public Passenger Vehicle (PPV) you will need to complete the relevant application, if you hold a current Tasmanian Ancillary Certificate it will be varied to include your Ride Sourcing details.

6. Declaration:

I certify that the above information is true and correct and understand that the Registrar of Motor Vehicles (RMV) will conduct random audits concerning fitness to drive (both medical and fit and proper). I also understand that I will be issued with an ‘X’ condition document which I am required to carry at all times whilst operating as a Ride-source driver.

I have read and understood the requirements associated with operating a Public Passenger Vehicle (www.transport.tas.gov.au/licensing/non-car-licence-or-ancillary/ancillary-certificates/legislative-requirements-for-operating-a-public-passenger-vehicle) and agree to abide by these rules whilst operating a Ride-source vehicle. I understand the RMV may require additional evidence to satisfy any concerns regarding my eligibility to hold an Ancillary Certificate at any time. Failure to comply with such a request may result in my Ancillary Certificate being suspended or cancelled.

I am aware that I will be operating a Ride-source vehicle under an exemption from the Transport Commission and will comply with all conditions and requirements attached to that exemption. I give permission for my Platform Provider specified in section 3 above to share information with the RMV concerning my Ride-source application (As detailed in section 5 of this application).
