Payment will only be made if:

- All interstate taxi vouchers claimed are submitted with this form.
- The form is submitted within three months of all claimed taxi trips occurring.

WAT trip subsidies (Hobart area - \$10, Launceston area - \$12, Devonport and Burnie areas - \$16) can only be claimed when taxi trips are undertaken by a wheelchair reliant person presenting a valid interstate taxi subsidy voucher and, the trip is undertaken in an approved Wheelchair Accessible Taxi.

Where a WAT trip subsidy is being claimed, the back of the voucher must be endorsed with the words "wheelchair passenger". The voucher must also be signed and dated.

Payment by the Department of State Growth for approved tax invoices will be made by electronic transfer to an account of your nomination.
