









Introduction

As part of ongoing maintenance and upkeep of the Light Vehicle Inspection Manual (LVIM) and to cater for recent legislation changes, Vehicle Standards Unit has now released version 23 of the LVIM.

This edition of the LVIM caters for the requirement for a vehicle without registration history to be included on the Australian Government Register of Approved Vehicles to be eligible for registration. Inclusions also cater for recent changes to Taxis as part of regulation changes.

Actions

Version 23 of the LVIM takes effect from 1 July 2023.

Vehicle Examiners must ensure they become familiar with version 23 as the current edition of the LVIM and apply the Reasons for Rejection to all future vehicle inspections conducted.
